Swordfish, antioxidants (E-300, E-301, E-331), water, and salt

### PRODUCT PRESENTATION

- Expanded polystyrene box with a thickness between 10-25 mm and wrapped in transparent self-adhesive octene polyethylene film. Individual pieces with an approximate weight of 5 kg.

- Expanded polystyrene boxes with a thickness ranging from 10 to 25 mm. Product enclosed in transparent bags made of HDPE and LLDPE with polyamide 6.6 straps and detectable metallic particles. Drained net weight format available in 3, 4, and 5 kg.
